### Notice of Proposed By-Law and House Rule Changes

At the regular Lodge meeting on October 17, 2018 revisions to both the Lodge By-Laws and House Rules were proposed in writing, read on the floor and laid over for a vote.

#### **By-Law Change:**

#### **Current By-Law: ARTICLE IV: MEETINGS**

**Section 1.** The regular Lodge meetings of this Lodge shall be held on the first and third Wednesday of each month throughout the year, except in the months of July and August, in which the Lodge shall meet on the third Wednesday.

#### **Proposed Change:**

**Section 1.** The regular Lodge meetings of this Lodge shall be held on the first and third Wednesday of each month throughout the year, except in the months of July and August, in which the Lodge shall meet on the third Wednesday.

**Summary:** Proposal would change the current requirement of holding two Lodge meetings per month to requiring only one Lodge meeting per month.

#### House Rule Change:

#### Current House Rule #16 (April, 2014)

In respect of our absent members, hats/headwear will not be worn at the bar. Exceptions may be granted by the bartender on duty or any elected officer present.

#### **Proposed Change:**

Eliminate House Rule 16.

By order of the Exalted Ruler, discussion and voting on these proposed changes will take place at the regular Lodge meeting, convening at 8pm, on December 5, 2018.

#### Ref: Grand Lodge Annotated Statutes, Section 17.060.

Amendments or revisions by By-Laws, Rules of Order and House Rules of a Lodge shall be proposed in writing, read at a regular meeting of the Lodge and laid over for a vote at a regular Lodge meeting to be held not less than two (2) weeks nor more than eight (8) weeks thereafter. Notice setting forth the full proposed amendment or revision of the By-Laws, Rules of Order and House Rules shall be sent to all members at least ten (10) days before the regular meeting at which the proposed amendment or revision is to be voted upon. A majority vote of Members at the meeting shall be required for adoption.
